<p>Acknowledgement Forms: All parents will be required to sign an updated “acknowledgements and notices” form before the start of the 2021-22 school year. These will be similar to the forms signed before the 2020-21 school year.</p>	<p>Every SACS family will receive forms and notices provided by the Office of Catholic Schools. These will be in addition to the handbook signature forms, emergency forms, etc. These forms and notices will be sent home to parents via the electronic Thursday Folder. <p>Weekly Data Collection: Schools will continue to complete the weekly survey from the Office of Catholic Schools on Covid-related matters until further notice in order to ensure consistent data collection efforts. <p>Virtual Learning - Individual Request:</p> <p>Permission must be given for children to attend our Catholic schools virtually in the 2021-22 school year. We believe it is best to have our students in person in our schools, whenever possible.</p> <p>Parents may make an application to the re-opening committee (not to the building principal) for consideration for virtual education. The application includes completion of a Google Form and an email including the needed medical documentation. Only medically-documented reasons will be considered. When the re-opening committee receives the application, the committee will consult with the building principal on the matter. The application, pertinent dates and email link can be found here.</p>	<p>SACS will not be offering a permanent option for simultaneous in-person and/or virtual instruction for the 2021-22 school year. It is most beneficial to have all our students present for in-person learning.</p> <p>In the event that a parent feels that his/her child should need a permanent virtual option, a request for consideration must be made to the Diocesan Re-Opening Committee (not the building principal). The application includes completion of a Google Form and an email including the needed medical documentation. <i>Only medically-documented reasons will be considered.</i> When the re-opening committee receives the application, the committee will consult with the building principal on the matter. <p>Virtual Learning - Response to Exposure:</p> <p>If quarantine is needed for a group of students, the school will strive to accommodate that group through a combination of virtual and traditional learning methods. Schools need to be prepared to offer virtual instruction in case an entire class needs to be quarantined.</p>	<p>If there is a need to quarantine, SACS teachers and administration will strive to accommodate individuals and/or small groups of students through a combination of virtual and traditional teaching methods. Teachers and parents must work together to decide on a schedule that best meets the needs of the individual child.</p> <p>In the event that an entire class needs to quarantine, SACS will</p>

<p>Temperature & Symptom Checks:</p> <p>Temperature checks will not be done on a daily basis; rather, they will be reserved for screening potentially ill students or faculty and staff.</p> <ul style="list-style-type: none"> • Parents will be asked to be vigilant in checking students for symptoms of illness and to keep students home when ill. • As details of specific symptoms of concern are known, the school will advise parents of any symptoms that require students to remain at home. • Faculty and staff are asked to do a daily self-check for symptoms. 	<p>Students and staff at SACS will not be screened for temperature or symptoms upon entry into the building; rather, they will be reserved for screening of potentially ill students and/or staff.</p> <p>SACS parents must be vigilant in checking for any symptoms associated with COVID or other illness prior to arriving at school. <p>Quarantines:</p> <p>Unvaccinated faculty, staff or students who are exposed to a Covid-positive person will need to quarantine based on time frames established by the CDC (see this link) and adopted by the Department of Health. Fully vaccinated faculty, staff and students will not need to quarantine, and no contact tracing is needed. Clearly, any student or faculty or staff member who tests positive for Covid must quarantine, with the length of the quarantine to be determined by the Department of Health.</p>	<p>SACS will follow guidance from the Diocesan re-opening team in regards to the state's regulations on quarantine information when there is a known exposure. At this time, we will follow the same protocol that we did in the 2020-21 school year unless told otherwise.</p> <p>Therefore, unvaccinated faculty, staff or students who are exposed to a Covid-positive person will need to quarantine based on time frames established by the CDC and adopted by the State of Pennsylvania. Fully vaccinated faculty, staff and students will NOT need to quarantine, and no contact tracing is needed. <p>Parents, visitors and volunteers:</p> <p>Parents, volunteers and other visitors will be allowed in schools.</p> <ul style="list-style-type: none"> • Those who are fully vaccinated will not be asked to wear masks. • Signage will be posted prominently in the lobby/office indicating that parents, visitors and volunteers in our school who are not fully vaccinated are asked to wear masks while in the school. • When signing in, parents, visitors and volunteers will sign that they understand and will comply with the request to mask if they are not fully vaccinated. No one will be asked for proof of vaccination when signing in. 	<p>SACS welcomes parents, visitors and volunteers to return to the school for the 2021-22 school year in accordance with guidelines stated in the student and parent handbook. Wearing a mask is a personal decision; however, we encourage those who are unvaccinated to wear a mask when visiting our school.</p> <p>Upon entrance into the building there will be signage stating our masking policy. Parents should sign-in with Mrs. Miller as per policy and will be asked to sign an acknowledgement to comply with our masking policy at the time of entrance. <p>Cleaning:</p> <p>Areas in schools for common use -- that is, used regularly by multiple groups within the school -- need to be cleaned regularly.</p> <ul style="list-style-type: none"> ● Locker rooms, gyms, band and chorus areas, and any other spaces used by multiple school groups are to be cleaned in the middle of the week, ideally, but at least once a week. ● Lunchroom surfaces need to be sanitized between lunch shifts. ● Classroom desks and high-traffic areas should be cleaned daily at the end of the school day. 	<p>SACS will make every effort to ensure that areas for common use are cleaned regularly. This includes spaces such as the gym, cafeteria, music, and restrooms.</p> <p>The cafeteria will be in use again for each lunch period. <p>Ventilation:</p> <p>Schools will make every effort to provide as much ventilation as possible in each classroom, as we did in 2020-21. Leaving windows and doors open in an appropriate manner is the simplest approach.</p>	<p>SACS will make every effort to provide as much ventilation as possible in each classroom, as we did in 2020-21. <p>Handwashing and hygiene:</p> <p>Students will be asked to wash/sanitize hands at sensible times, as always: at start and end of the school day, before and after lunch, when they have sneezed or used the restroom, and as needed. Water fountains may not be used. Schools may ask students to bring water bottles to school.</p>	<p>SACS will ask students to wash and sanitize hands at sensible times throughout the day which may include but are not limited to arrival, before meals, after recess, etc.</p> <p>SACS water fountains will remain turned off and closed. Students will have access to water at three refilling stations. Proposed trips beyond the local area are to be brought to the Secretary for Education for discussion. <p>Social, emotional and spiritual care for students: We need to make sure, in each school, that we are carefully monitoring student learning and providing all possible resources to meet individual learning needs and to provide the best resources for social, emotional and spiritual growth for our students. As we did last year, we will take a team approach in our schools: school nurses, counselors, social workers (if available) and priests will bring powerful resources to benefit our students. That team will need close collaboration with parents and with teachers, who know the needs of their students well.</p>	<p>SACS cares deeply about the social, emotional, and spiritual needs of students and staff. It is evident that some learning loss occurred over the last two years due to the on-going pandemic. To combat learning loss, two new academic programs have been added to the K-5 classrooms.</p> <p>SACS will take a team approach to address the needs of students. Our Student Support Team (SST) has reorganized with new members and is ready to work collaboratively with teachers and parents, who know the needs of their students well.</p> <p>To address the spiritual needs of students, all school Masses will resume. Prayer Buddies will be reinstated. Additionally, students will participate in Mass on Holy Days, plan prayer services, and celebrate special religious holidays. Students will also resume participating in giving time and talent to the school, parish, and community.</p>

<p>Groupings- Cohorts and Small Group Work:</p> <p>While we will not start the year with the strict cohorting system we used last year, each school is asked to plan the daily interaction of student groups. Each school will determine the range of those groups. In the end, if there is a potential exposure to Covid, we need to know how to proceed. As an example: a school may decide that one group will be grades K-2, as they need to eat lunch at the same time.</p> <p>Schools may have small groups work together within the classroom. Maintain the three-foot distance, to the extent feasible.</p>	<p>SACS will not start the school year with a cohorting system. The school will resume operating together again as a primary, intermediate, and middle school wing.</p> <p>Small group and partner work will resume in the classroom. <p>Groupings - Cafeteria: The cafeteria may be used. To the extent feasible, students should be three feet apart in the cafeteria. Commonly-used surfaces in the cafeteria must be cleaned between lunch shifts. A clean and simple approach for the school is to make the groups mentioned above the same as the lunch groups that share the cafeteria.</p>	<p>SACS will resume using the cafeteria for lunch periods. Students will eat with their designated wing (K-2, 3-5, & 6-8). Students will be seated at designated tables and will be at a minimum of three feet apart.</p> <p>All surfaces used during each lunch shift will be wiped and sanitized.</p> <p>Keystone Family Kitchen will continue to provide our school with individually packaged lunches each day to allow for less opportunities of contamination and easy clean-up.</p> <p>As three feet apart cannot be maintained with the entire student body during morning drop-off, students will proceed to homerooms for prayers and announcements via Google Meets.</p> <p><u>Lead Individuals:</u></p> <ul style="list-style-type: none"> • Lunch Monitor • Specials Teachers • Custodian <p><u>Materials:</u></p> <ul style="list-style-type: none"> • Trash Cans • Cleaning Solution • Clean Cloths • Hand Sanitizer

<p>Groupings - Assemblies: Schools may have assemblies, as needed. As assemblies will bring together more than one school group, schools are encouraged to start with a small number of assemblies in the first quarter of the school year, until we see the overall impact.</p>	<p>SACS may resume scheduling assemblies for the 2021-22 school year starting with a small number during the first quarter of the school year.
